Initiating the discussion, Principal Secretary Planning apprised the Chairman & Members about the purpose of Border Area Development Programme, its criteria for allocation of funds and its guidelines.

## Item No.1 Confirmation of the Minutes of the Meeting of State Level Screening Committee held on 24/05/2010

#### Item No.3 Utilization of Funds 2009-10

Deputy Commissioner, Gurdaspur intimated that the Army authorities have declined permission for construction of high level bridge at Ghaniya Ke Bet for which the GoI released Rs. 7.75 crore during 2009-10. It was decided that Deputy Commissioner, Gurdaspur in consultation with Army Authorities will examine if a Pantoon Bridge can be constructed at Ghaniya Ke Bet. Of the remaining amount a sum of Rs.2.00 crore will be utilized for special projects including for a Pantoon Bridge across river Tarna in Bamial Block (Gurdaspur). Deputy Commissioner will identify more special projects for the surplus amount.

# Item No. 10 Recommendation of the Inspection team of Planning Commission regarding Construction of Pantoon Bridge over river Tarna in Bamial Block, District Gurdaspur

The construction of new bridge was approved subject to the clearance from Army authorities. Rs. 2.00 crore amount may be utilized out of the funds of Rs. 7.75 crore rendered surplus with the dis-approval of Army authorities for construction of high level

bridge at Ghaniya Ke Bet, District Gurdaspur. For the remaining amount, district Gurdaspur shall submit an alternative proposal of special project with the approval of Chief Secretary, Punjab for approval of GoI.

## Item No.11 Follow up of the meeting of the Empowered Committee on BADP held on 3/5/2011 at New Delhi

The SLSC took note of the observations/decisions taken in the meeting. The MIS should be implemented. Shortly, the BADP is being put online by the GoI including Baseline Survey, Annual Action Plan and Financial and Physical Reports. The Baseline Survey is already online, all the districts should ensure completion of entries and its revision every six months. Necessary hardware should be placed at the Block/District level and capacity building of concerned officials be undertaken immediately. As far as possible parking of BADP funds should be avoided. In case any interest is earned, it should be accounted for and used for BADP works. The Deputy Commissioners were asked to take appropriate steps to implement the instructions/guidelines of GoI.
