A Meeting of the State Level Screening Committee for BADP was held on 11/07/2018 at 10.00 AM under the chairmanship of Principal Secretary, Planning Punjab.

List of participants is annexed at Annexure 'A'.

At the outset Principal Secretary Planning explained that the objective of the Border Area Development Programme (60:40) is to meet the special development needs of the people living in remote and inaccessible areas situated near the International Border and to saturate the border areas with the entire essential infrastructure. He further intimated that for the year 2018-19, the Government of India has allocated an amount of Rs 32.67 Cr (CS: Rs 19.60 Cr + SS: Rs 13.07 Cr) for the state of Punjab. The following decisions were taken on the agenda items discussed in the meeting:-

**Agenda Item No.1 : Approval of Annual Action Plan for 2018-19**

State Level Screening Committee approved the Annual Action Plan of Rs 32.67 Cr (CS: Rs 19.60 Cr + SS: Rs 13.07 Cr) for the year of 2018-19. The District wise Annual Action Plans alongwith District wise / Sector wise summary as approved in the meeting are enclosed.

**Agenda Item No.2 : Review of submission of UCs of previous years**

The progress of expenditure incurred and works executed under BADP in the previous years was noted. It was decided in the meeting that Deputy Commissioners of the concerned Border District would supply the pending UCs at the earliest.
