



**Subject:- Minutes of the State Level Screening Committee (SLSC) meeting held on 20/11/2014 at 10.00 AM, Punjab Civil Secretariat, Chandigarh.**

Kindly refer to the subject cited above.

2. List of participants annexed at Annexure-'A'.
3. At the outset Secretary Planning explained the objective of the Border Area Development Programme to meet the special developmental needs of the people living in remote and inaccessible areas situated near the International Border by filling the missing gaps and further explained that GoI has allocated an amount of Rs.35.26 crore under BADP (Normal) for the year 2014-15. The progress of funds released during 2011-12, 2012-13 must be 100% and 2013-14 may be 50% at the time of the release of 2<sup>nd</sup> Instalment for the year 2014-15 as per the GoI Guidelines. The representative of the BSF has requested to include 4 specific schemes for the Amritsar Sector, Secretary Planning suggested that they should send their proposals to the Deputy Commissioner, Amritsar for consideration.
4. **Utilization of funds**
  - I. **Utilization of 2011-12** – Secretary Planning asked the Deputy Commissioner, Amritsar about the progress/UC of pending amount of Rs. 13.50 lac. The Deputy Commissioner assured that the utilization of Rs.10.00 lac will be submitted within 3-4 days and also informed that efforts are being made to recover the balance amount of Rs. 3.50 lac and FIR has already been lodged against the Ex-Sarpanch of Village Kaunke.
  - II. **Utilization of 2012-13** – Deputy Commissioner, Ferozepur informed that the balance UCs amounting to Rs.3.48 lac will be sent shortly. Deputy Commissioner, Pathankot informed that Rs.3.50 lac embezzled by Sarpanch of Village Datial, Block Narot Jaimal Singh and FIR has been lodged against him on dated 18/11/2014. He also informed that the balance UCs amounting to Rs.2.99 lac will be submitted very shortly.
  - III. **Utilization of 2013-14** – Secretary Planning explained the Deputy Commissioners to make ensure that minimum 50% UCs alongwith QPRs submitted to the Planning Department by 15<sup>th</sup> December, 2014 as per the Guidelines of GoI, so that the 2<sup>nd</sup> instalment may also be obtained from the GoI well in time.



## 5. Allocation of funds for 2014-15

5.1 The Secretary Planning explained the proposals submitted by the 6 border districts for the year 2014-15 and the Chairman of the State Level Screening Committee (SLSC) approved the allocation, the summary statement is as under:-
