Subject:- Minutes of the State Level Screening Committee (SLSC) meeting held on 28/07/2015 at 3.30 PM, Punjab Civil Secretariat, Chandigarh.

A meeting of the State Level Screening Committee of BADP was held under the Chairmanship of Chief Secretary Punjab on 29.07.2015.

- 1. List of participants is annexed at Annexure-'A'.
- 2: At the outset Secretary Planning explained the objective of the Border Area Development Programme to meet the special developmental needs of the people living in remote and inaccessible areas situated near the International Border by filling the missing gaps and also explained that as per the modified guidelines of Border Area Development Programme (BADP) June, 2015, it is a 100% Centrally funded programme to cover all the villages within 0 to 10 km of the International Border on 1<sup>st</sup> priority thereafter 0 to 20 km and so on upto 0 to 50 km. of the Border Block abutting on the International Border. The Government of India has allocated an amount of Rs. 38.14 crore including Rs. 2.87 crore for ongoing works of 2014-15 (Rs. 1.80 Cr balance of the previous year and Rs. 1.07 crore of the pending UCs submitted upto 2013-14). The agenda items were taken up thereafter.

#### 3. Agenda Item No. 1

SLSC approved the Annual Action Plan of Rs. 3527.46 lac for the year 2015-16. It was decided that Government of India be requested to allow the state to take up works upto 0-20 km strip alongwith international Border as it in past.

## Agenda Item-II

SLSC approved the Rs. 286.54 lac for the completion of ongoing scheme of 2014-15. It was also decided that Government of India be requested to release additional funds amounting to Rs. 131.35 lac for already approved Annual Action Plan of Rs. 3108.40 lac for the year 2014-15 to complete the remaining balance works.

## Agenda Item-III

The proposal of up-gradation of existing PHC to CHC at Attari was also discussed in the meeting and it was decided to keep it pending for the time being.

### Agenda Item-IV

The progress of expenditure incurred and works executed under BADP in previous years was noted.

Principal Secretary Health and Family Welfare pointed out that the residential quarters for doctors and paramedic staff be constructed in the dispensaries of Border Areas, so that the better medical care be given to the people. The Chief Secretary directed the Deputy Commissioners to identify the conditions of the already existing dispensaries in border areas and in future earmark funds for their repair. It was also decided that the Deputy Commissioners will submit the certificates regarding completion of works.

The meeting ended with a vote of thanks to the chair.
