The Governor of Punjab is pleased to constitute an Apex Committee for promoting the role of Non-Government Organizations(NGO's) in the development of State as under:-

2. The Apex Committee can associate any Administrative Secretary or Officer or any other expert as special invitee as may be required from time to time.

3. The Apex Committee shall meet from time to time and at a place to be decided by the Chairman of the Apex Committee. The functions of the committee shall be as under:-

- a) To provide overall guidance and guidelines for involvement of the NGOs in development work in Punjab;
- b) To review the physical and financial performance of the concerned Administrative Department for promotion of role of the NGOs in development works and to take remedial steps for removing bottle necks, if any ;
- c) Any other function as decided by the Chairman.

4. The non-official expert called as special invitee in the meeting shall be entitled to TA and DA equivalent to the Grade-I officers of the State Government. The TA and DA in such cases shall be payable from the scheme PM 1.10 "Assistance to NGO's".

5. The term of the committee shall be for three years.
